I. General Policy

- a. Tennis Courts under the jurisdiction of the Hayward Area Recreation and Park District (HARD) are intended for recreational use by District residents in conjunction with District sponsored programs and classes.

II. Tennis Court Hours

- a. District tennis courts are available for use from 8:00am-10:00pm unless otherwise posted.
- b. Courts are available for reservation (permit) during all operational hours.

IV. Tennis Court Rules and Regulations

- a. Tennis courts are first come/first serve unless reserved/permited.
- b. Non-permitted/reserved court use is limited to one-hour, if other players are waiting.
- c. One player may not "hold" a court if players are waiting to play.
- d. Tennis courts are designated for tennis only- no skating, biking, skateboarding or other non-tennis activities are allowed.
- e. Do not disrupt play when entering court or retrieving balls.
- f. Tennis shoes are required- no black soles or bare feet allowed.
- g. No food or animals are permitted in court areas.
- h. Vandalism or misuse of courts may result in fines or penalties by Park Rangers or Local law enforcement agency.

IV. Tennis Court Rules and Regulations (cont.)

- i. Any reserved or permitted player/ group must possess permit for any request for verification of court reservation.
- j. No smoking is allowed on District property.
- k. Use of HARD tennis courts for private instruction or personal gain/profit is prohibited. ONLY District authorized tennis instruction is permitted on HARD tennis courts.

IV. Tennis Court Reservations

a. Court Reservation Permits/Fees

1. Groups or individuals may reserve courts **90 days in advance** at the cost of \$9.00 per court hour. ½ hour increments are available for \$4.50. (One hour reservation minimum is required).
2. Reservations for individuals are limited to two-hours / per court / per day/ per permit and groups to 3 hours per court use/ per day/ per permit.
3. A MINIMUM of one court per facility will NOT be reserved or permitted and be made available to the public on a first come/first served basis.
4. Group reservations must be made by a single point of contact (Team Captain).
5. All court rental fees are due *at the time of the reservation*. No reservations dates, courts or times will be held unless payment is received.
6. Reservation credit will be given for weather /unplayable court surfaces (rain) or reservations cancelled by HARD.
7. **No refunds will be given unless there is a cancellation by H.A.R.D., or due to rain. Rainouts need to be called in within one WEEK of your rental date. All long-term reservations are subject to cancellation for H.A.R.D. activities.**
8. HARD priority for use and permitting of courts:
 - a. HARD /DISTRICT Programs and classes
 - b. Co-sponsored Programs and classes (i.e. School District Tennis Teams)
 - c. Individuals /Group Use
9. Cancellations of reservation permits must be received (5) business days prior to use or will incur a \$5.00 service charge. A full credit/refund will be provided for cancellation due to District cancellation or rain.
10. No Holiday reservations will be processed without prior approval of District Representative Supervisor or Superintendent.
11. Permitted individuals or groups must provide copy of permit if requested by other players or District Representatives.
12. Permits will not be issued for any "for profit" event, class, tournament or activity. "Permittee" must disclose and receive DISTRICT permission *in advance* of any reserved tennis court activity in which fees or monies are collected and must demonstrate that activity is of public / non-profit benefit.
13. A fee of \$2.00 per date will be added to reservation fees for any changes with the exception due to rain-outs.
